

The Windsor-Essex Parkway

NOTICE OF DESIGN AND CONSTRUCTION REPORT #7A REVIEW OPPORTUNITY

Part A of the seventh Design and Construction Report (DCR), for the Windsor-Essex Parkway documents the proposed construction works along the corridor, associated mitigation measures and how public input received to date and commitments outlined in the Detroit River International Crossing Provincial Environmental Assessment Report (December 2008) and the associated Conditions of Approval (August 2009) have been addressed. The Design and Construction Report is available for a 30-day public review period starting **Monday, October 29, 2012, after 3:00 p.m.**, at the locations listed below, as well as online at www.weparkway.ca.

PROPOSED WORKS

The works in Design and Construction Report #7A include:

- Temporary long-term E.C. Row Expressway single laning from west of Matchette Road to west of Huron Church Road
- Closure of access to and from Outer Drive and to and from Highway 3
- Diversion D-14, Sandwich West Parkway
- Cousineau Road closure at Highway 3
- Bridge 2, over Matchette Road
- Bridge 6, north of Spring Garden Road
- Bridge 12, future off-ramp from Highway 401 westbound to Highway 3

Although listed in this order, many of these activities will occur in parallel with one another. The detailed design for the remaining components of the Windsor-Essex Parkway will be addressed in future Design and Construction Reports.
